UNOFFICIAL RESULTS

Unofficial Results – Monday, April 12 after Close of Polls

Unofficial results are based on statements of the poll reported to returning officers after the count of ballots on Monday, April 12, 2021. The results from 175 polls (polling day polls, special ballots and advance polls) are tallied, phoned into returning offices, and reported by the returning officers.

The Official Addition – Thursday, April 15, 2021 at 10AM

The Official Addition is the addition of the vote totals from the official statements of the poll conducted by the returning officer.

Following the close of polls, sealed ballot boxes along with documentation are returned to the returning officers for the official addition. Ballot boxes are opened and from the official statement of the poll, officially add up the number of ballots cast for each candidate and the number of rejected ballots.

Immediately after the Official Addition, the returning officer will declare and cause to be published the name of the candidate for whom the greatest number of ballots have been cast.

Application for a Recount

Immediately after the Official Addition, if there is an equality of ballots cast for two or more candidates or the difference between the number of ballots cast for the candidate receiving the greatest number of ballots and another candidate is 10 or less, the returning officer will apply for a recount to a judge of the Supreme Court.

The judge shall appoint a time for the recount which will be within four days of the application.

Tie Determined by Drawing of Lots

If, after the recount, there remains an equal number of votes cast between two or more candidates, the election shall be decided immediately by the drawing of lots by the returning officer in the presence of the judge and any candidate or candidate's representatives.

Voter Turnout (Participation Rate)

Voter turnout is based on the ratio of the number of voters to the number of electors.

2021 TERRITORIAL GENERAL ELECTION OFFICIAL RESULTS

The Official Addition was conducted today in the 19 returning offices across the territory. This process involves opening the sealed ballot boxes to remove the statement of the poll and to officially add up the numbers of ballots cast for each candidate and the number of rejected ballots.

On completion, the returning officer declare the name of the candidate for whom the greatest number of ballots were cast. A Certificate of Official Addition is produced and signed. This is the official count. Candidates are provided copies.

Application for a Recount

Immediately after the Official Addition, if there is an equality of ballots cast for two or more candidates or the difference between the number of ballots cast for the candidate receiving the greatest number of ballots and another candidate is 10 or less, the returning officer will apply for a recount to a judge of the Supreme Court.

The judge shall appoint a time for the recount which will be within four days of the application.

Tie Determined by Drawing of Lots

If, after the recount, there remains an equal number of votes cast between two or more candidates, the election shall be decided immediately by the drawing of lots by the returning officer in the presence of the judge and any candidate or candidate's representatives.

Voter Turnout (Participation Rate)

Voter turnout is based on the ratio of the number of voters to the number of electors.

PUBLIC HEALTH

Elections Yukon has been working in collaboration with the Department of Health and other electoral agencies to ensure a safe and secure process. Electors will be required to wear a mask at offices and polling places and to follow COVID-19 Safe 6 measures.

ELIGIBILITY

To be eligible to vote an elector must:

- Be a Canadian citizen, and
- At least 18 years of age on polling day, and
- Have been resident in Yukon for twelve months prior to polling day.

REGISTRATION

Registration is required to vote. If not registered, electors will need to register. Identification is required to register and to apply for special ballots. Registered electors at the correct address will not be required to show identification at the polls.

WAYS TO VOTE

There are three ways to vote.

- Special Ballots: In person or online/Mail. Applications are available until the Friday before Polling Day. Completed ballots must be returned to your local returning office or Election Yukon Headquarters (by mail or Headquarters drop box) by close of polls (8 PM) on April 12, 2021.
- Advance Polls: In person Sunday April 4 and Monday April 5, 2021 (Easter weekend), the week before polling Day.
- Ordinary polls: In person on Monday April 12, 2021.

KEY DATES:

Throughout the Election Period - Recruiting

- Election Yukon will require election officials to work at Advance and Ordinary polls during the election.
- Applications to be part of the Elections Yukon team to work during the election period can be made at the returning offices or online at electionsyukon.ca.

Friday March 12, 2021 Issue of Writ

- Returning Offices are ordered to open to conduct a territorial general election in the 19 electoral districts.

Saturday March 13, 2021 Returning Offices Open

- Electors can register or update their registration online, by mail, by email (register@electionsyukon.ca) or at any returning office.
- Electors can apply for special ballots online at electionsyukon.ca or by mail or email to Elections Yukon. Identification is required.
- Electors can apply for a special ballot at any of the 19 returning offices. Identification required.
- Candidates can submit their nominations papers from the issue of the writ until Nomination Day on March 22, 2021 at 2 PM.

Monday March 22, 2021 Nomination Day at 2 PM

- Nomination of candidates will close at 2 PM in the returning office. Early submission of nomination papers is encouraged.

Sunday and Monday April 4 & 5, 2021 (Easter weekend) Advance Polls

- In-person voting. If not registered, can register at the advance poll. Identification is required.
- Advance polls are open 8 AM to 8 PM.

Friday April 9, 2021 End of Application Period for Special Ballots

- End of period to apply for a special ballot. Identification is required.
- Special ballots must be received by either the returning office for the electoral district of the elector or at Elections Headquarters (by mail or the Whitehorse drop box).
- Ballots received after 8 PM will not be counted.

Monday April 12, 2021 Polling Day

- In person voting. If not registered, can register at the polls to vote. Identification is required.
- Ordinary polls are open 8 AM to 8 PM.
- Unofficial results will be released after the polls close and ballots are counted.
